

Privacy Policy

TrueAccord Corp. (“Us”, “We”, or “Our”) is committed to protecting your privacy online. This Privacy Policy discloses the manner in which TrueAccord Corp. collects, uses, maintains and discloses information collected from users (“You” or “Your”) of the trueaccord.com website and various related services (together referred to as the “Site” or “Services”). This privacy policy applies to the Site and all products and services offered by TrueAccord Corp.

By accessing this Site, You acknowledge that this Privacy Policy is part of Our Terms of Use and agree to be bound by all of the terms found herein. If You do not agree to these terms, please do not use the Site or Services.

TrueAccord Corp. reserves the right to modify this Privacy Policy at any time. Changes, modifications, additions, or deletions are effective immediately upon notice, which may be given by means including, but not limited to, issuing an email to the email address listed by registered users, or posting the modified Privacy Policy on this page. When changes are made, We will revise the last updated date at the bottom of this page.

We encourage you to frequently check this page for any updates. Personal identification information

We do not collect any Personal Identification Information about you unless you voluntarily provide it to Us. We may collect personally identifiable information from you that let’s us know the specifics of who you are in a variety of ways, including, but not limited to, when you visit the Site, register on the Site, place an order, respond to a survey, send us feedback, fill out a form, and in connection with other activities, services, features or resources we make available on the Site. We may ask you to provide your personal information, such as your first and last name, email address, mailing address, phone number, credit card information and other personal identifying information. We may also collect information from you at other points on the Site that state that such information is being collected.

You may visit the Site anonymously and choose not to provide the requested personal information. You can always refuse to supply personal information, except that depending on the activity, some of the information that we may ask you to provide may be mandatory. Non-personal identification information

We may collect non-personally identifiable information that does not by itself identify a specific individual when a user interacts with the Site. This information is compiled and analyzed on both a personal and an aggregated basis. An IP address is a number that is automatically assigned to your computer when you access the internet, allowing web servers to locate and identify your computer. Your computer requires an IP address in order for you to communicate on and access the internet.

This information is used to diagnose problems with Our servers, software, to administer Our Site, and to gather demographic information.

Web browser cookies

When you use the Site, We may use “cookies” to enhance your user experience. A cookie is a small data file stored on your computer by a website for record-keeping purposes and sometimes to track information about you. You may choose to set your web browser to refuse cookies, or to alert you when cookies are being sent, but some parts of the Site may not function properly without accepting cookies.

Tracking requests

Our Site does not recognize or act on Do Not Track requests from your browser. The information We receive through tracking is used to provide a more personalized user experience to you.

How We use collected information

We do not share collected information with outside parties except to the extent necessary to provide the Service. We may collect and use Your personal information primarily to provide the Services to You, which may include, but is not limited to, the following purposes: To improve customer service by allowing us to respond to your customer service requests. To enhance a user's experience on our Site we may use personal information and feedback in the aggregate to understand how all of our users as a group use the services and resources provided on the Site. To improve the Site we may use feedback you provide to Us. To process payments We may use the information users provide about themselves when placing an order only to provide the Services requested by You. To contact You regarding administrative notices, resolve disputes, troubleshoot problems with You, and to respond to inquiries, questions, and other requests.

How We protect your information

We adopt appropriate data collection, storage and processing practices and security measures to protect against unauthorized access, alteration, disclosure or destruction of Your personal information, username, password, transaction information and data stored on the Site. Sensitive and private data exchange between the Site and its users happens over a SSL secured communication channel and is encrypted and protected with digital signatures. We recommend that you do not divulge your password to anyone.

Unfortunately, no data transmission over the Internet or any wireless network can be guaranteed to be 100% secure. While We strive to protect your information, you acknowledge that: there are security and privacy limitations beyond our control; the security, integrity, and privacy of any and all information exchanged between You and Us cannot be fully guaranteed; and any such information and data may be viewed or tampered with in transit by a third party.

Sharing Your personal information

We do not sell, trade, or rent Your personally identifiable information to others.
